

## HONEY ROCK BOTTOMS LLC HUNTING CONTRACT – FIREARM DEER

**In consideration for the HONEY ROCK BOTTOMS LLC accepting my application and fee, and being permitted to participate with HONEY ROCK BOTTOMS LLC, I agree to this release of claims, waiver of liability and assumption of risk, with conditions as follows:**

\*\*\* Deposit of hunt is due within at the time of booking your hunt. \$500.00 required for weekend hunts and \$250.00 for 1 day hunts.

\*\*\* Deposit will be refunded if the Hunt is canceled within 30 days of the booking date. Deposits can be reapplied to a rescheduled hunt within the same hunting season.

\*\*\* Deposit payment required before hunting begins. Then full payment once hunt concludes.

\*\*\* We cannot assure you a hunt until we receive the deposit.

\*\*\* Weather may affect the ability to hunt.

\*\*\* License fees are the responsibility of the hunter. You will need a Texas hunting license and your own tags. \*\*\* No lodging facilities exist

\*\*\* No ATV's allowed.

\*\*\* A valid driver's license or ID is required.

\*\*\* HONEY ROCK BOTTOMS LLC requires target practice prior to the hunt to assess the hunter's skill level and ability.

\*\*\* All hunters must provide their own appropriate hunting clothes and food.

\*\*\* Hunters must bring their own guns and ammunition. Guns and ammunitions are not provided. Guns must be in excellent working order or will not be allowed to be used.

\*\*\* Hunt price is for two doe with all packages--taking a deer is not guaranteed. Size is not guaranteed, and all scores and ages are estimated.

\*\*\* HONEY ROCK BOTTOMS LLC does not provide deer processing. Hunter is responsible for processing and mounting. HONEY ROCK BOTTOMS LLC will take to a local processor for a fee.

\*\*\* Not locating the deer shot or wounded constitutes a kill and full payment is required. If the deer is later found, transportation for the trophy will be arranged.

\*\*\* HONEY ROCK BOTTOMS LLC support wildlife management and require all hunters to comply with the laws of the State of Texas.

\*\*\* Hunters must come financially able to pay in case of a kill. Failure to pay in the case of a kill will result in the lifetime ban from HONEY ROCK BOTTOMS LLC and your deer will be confiscated.

\*\*\* **HONEY ROCK BOTTOMS LLC requires all hunters to be accompanied by a Guide. HUNTERS AGREE TO OBEY THE INSTRUCTIONS OF THE GUIDE DURING THE HUNT. FAILURE TO COMPLY WITH THE DIRECTIONS OF THE GUIDE OR DISOBEYING THE GUIDE WILL RESULT IN THE IMMEDIATE HALT OF THE HUNT AND THE EXPULSION OF THE HUNTER AND ANY PARTY MEMBERS OF**

**THE HUNTER FROM THE PREMISES. HONEY ROCK BOTTOMS LLC WILL NOT REFUND ANY MONEY PAID FOR THE HUNT IN THIS SITUATION.**

**\*\*\*THE GUIDE HAS THE FINAL AUTHORITY REGARDING THE HUNT. THE DECISIONS OF THE GUIDE MUST BE FOLLOWED. FAILURE TO FOLLOW THE INSTRUCTIONS OR DECISIONS OF THE GUIDE WILL RESULT IN IMMEDIATE EXPULSION FROM THE HUNT AND LAND WITHOUT ANY REFUND.**

**\*\*\* If you shoot any livestock during the hunt you will be required to pay market price for the injured livestock.**

**\*\*\* Returning to the property or premises without a guide will constitute trespass and the Hunter will be banned from any future hunts.**

**\*\*\* Firearms must comply with Texas regulations.**

**\*\*\* HONEY ROCK BOTTOMS LLC reserves the right to terminate the hunt of any hunter and his/her party for not complying with the above-stated rules and regulations.**

**\*\*\* UNDERAGE HUNTERS**

**If you are 17 years old or younger, you MUST be accompanied by a Legal Guardian.**

#### **WAIVER OF LIABILITY**

I, the undersigned, attest and affirm that I know and understand that the sport of bow and gun hunting is a potentially dangerous activity and that I should not participate in such activity unless I am medically and physically able. I assume all risks associated with participating in a hunt with HONEY ROCK BOTTOMS LLC including but not limited to, injuries from falls, injuries from animals, effects of weather, dangerous conditions, or injury resulting from faulty personal equipment and the acts of other hunters.

Having read this waiver and in consideration of HONEY ROCK BOTTOMS LLC, accepting my participation in a bow or gun hunt, I hereby waive now and in the future any claims I may have against and release from liability and agree not to sue or allow my executors, heirs or insurers to sue HONEY ROCK BOTTOMS LLC, its agents, officers, shareholders, landlords, landowners, or employees from all claims or liabilities for any personal injury, death, property damage, or loss of any kind arising out of my participation in a bow or gun hunt provided by HONEY ROCK BOTTOMS LLC, including without limitation, negligence on the part of HONEY ROCK BOTTOMS LLC or its staff. Any claims will be settled under TEXAS law.

This waiver and release shall be binding upon the undersigned, his/her heirs, executors and assigns or anyone entitled to act on his/her behalf.
